

## WILDLIFE AND COUNTRYSIDE LINK TOP TWENTY POLICY PRIORITIES TO TEST DELIVERY OF THE BIODIVERSITY STRATEGY FOR ENGLAND

Members of Wildlife and Countryside Link's Biodiversity Task Force (BTF) participate fully in the Biodiversity Action Plan process at national, regional and local levels. The BTF members are collectively Lead Partners for around 200 species, and are actively involved with a number of species and habitat BAP groups. Link has identified twenty policy priorities outlined in the England Biodiversity Strategy which it believes will act as key tests for the delivery of the strategy. Delivering on these priorities should not be seen as representing all that is needed for biodiversity conservation, but simply as an indicator of whether sufficient critical action is being taken to implement the Strategy.

Here we provide Link's first assessment of progress made with implementing these priority actions in the first year since the launch of the Strategy. The long-term test of biodiversity improvement will be the relative performance of the headline indicators categorised by sector (as shown in the indicator report):

- Status of wild birds
- % of SSSIs in favourable condition
- Status of BAP priority species and habitats
