# **Parliamentary Briefing**

# Marine and Coastal Access Bill Amendment

**Membership of IFC Authorities (Clause 147)** 

The organisations listed above are all members of Wildlife and Countryside Link's Marine Task Force<sup>1</sup>, which has been campaigning for several years for improvements in marine conservation and better management of the marine area. We have been closely engaged in the Marine & Coastal Access Bill process from the outset.

#### **Background**

Link considers it very important for the new IFCAs to be distinct in *composition and culture* from the existing SFCs. To ensure this requires the composition of the authorities to be spelt out in the Act more clearly than at present, specifically with a requirement for representation from EA and NE and an equal balance of the two main special interests – fishing and conservation.

This suggestion will not lead to an "overbalancing" in favour of conservation because clause 147 (1)(a) provides that as well as the kinds of members referred to above there must also be representatives of each relevant local authority. We recognise that IFCAs must have representation from local authorities, as they are funding bodies, and to ensure local participation and buy-in to decisions. However, experience with the current Sea Fisheries Committee system demonstrates that due to their make-up, SFCs have often favoured fishing concerns over conservation necessities. We therefore believe that there should be a requirement in clause 147 to balance numbers of people with fishing and conservation interests.
