Dear Chancellor

We are writing to raise concerns about alleged cuts of up to £200m from Defra's budget. Collectively, Wildlife and Countryside Link's members have the support of approximately 8.4 million people in the UK. We are alarmed that budgets appear to be being cut in such a drastic way. The short term benefit of such cuts will be substantially outweighed by the longer-term economic and environmental costs.

We are seriously worried that the budget for Natural England has been cut before the organisation has even been formally established, and support the assertion of Sir Martin Doughty, the new Chairman of Natural England, that "the scale of these cuts risks the wheels coming off the organisation even before it reaches October's launchpad". This organisation should be 'delivering more than the sum of its parts' from early on, and these cuts make that far less likely.

The Government has made significant advances towards more environmentally sustainable agriculture support, particularly through the agri-environment schemes. We are troubled by cuts to the funding of these schemes. Adequate funding of the higher-level Environmental Stewardship scheme is essential if Government commitments to the UK Biodiversity Action Plan (BAP) are to be met, in terms of species and habitats. The scheme is also vital to ensure management and enhancement of traditional agricultural landscapes, their character, and their historic and archaeological features. Furthermore, despite recent progress, the delivery of well established Public Service Agreement targets for farmland birds and Sites of Special Scientific Interest will be jeopardised without adequate levels of funding. It is also the means by which wider public benefits, such as an attractive countryside available to all, can be delivered.

In the light of climate change, the case for continued investment in our environment should be more firmly on the agenda than ever in the run up to the Comprehensive Spending Review. Such investment will be essential to stay on track to halt biodiversity loss by 2010, and support the land management associated with important habitats and landscapes. Furthermore, healthy biodiversity will ensure that our ecosystems will continue to benefit society as a whole, while well managed and attractive rural landscapes are vital to the nation's well being, quality of life and attractiveness to tourists from around the world. Indeed, 40 percent of the jobs created through tourism
