Dear Members,

The first quarter of 2007 has seen the long awaited publication of the Marine Bill White Paper, and Link continues to urge the Government to publish a full Marine Bill early in the next Parliamentary session. The recent grant from the Esmée Fairbairn Foundation and Tubney Charitable Trust to appoint a full time Marine Policy and Campaigns Co-ordinator to support Link's Marine Bill campaign will increase capacity within the Secretariat and ensure that we are getting our message out clearly over the next few years as this process continues.

During the quarter the Biodiversity Working Group joined forces with Wales Environment Link to publish the first annual assessment of progress towards the Government's target of halting biodiversity loss by 2010, based on the indicators set out in the Joint Links 2010 leaflet. The long awaited outcome of the saga of the Rural Development Programme for England 2007 - 2013 was also announced in March and Link is continuing to monitor developments in this area, particularly around concerns regarding the potential impact on Higher Level Scheme agreements.

Finally, in 2006, we asked you for your comments on this quarterly report. In response to the feedback received we plan to change how we communicate with the membership over the coming months and as a result this will be the last Quarterly Report produced.

We are currently looking at the best way in which to communicate with our members, and so if you have any suggestions you'd like to make please let Link know!

Biodiversity

In January Link launched its first annual assessment of the progress made towards the Government target of halting biodiversity loss by 2010. Presented in a traffic light system, the results of the assessment were mailed electronically and launched on Link's website. Copies of the full assessment document are available for download from www.wcl.org.uk/2010/2010_assessment.htm

Members of the Biodiversity Working Group (BWG) met with JNCC in February to discuss the JNCC's ideas for a UK nature conservation framework and a UK surveillance strategy. Representatives of the BWG also attended a workshop in March hosted by Barry Gardiner MP, looking at how to refresh the biodiversity partnership in England. Link gave a presentation on the role of the biodiversity process in delivering large scale habitat restoration and ecosystem services. This was a positive and constructive event, and we now look forward to working with the Minister, Defra and other partners in taking the outcomes forward.

The BWG's BAP Review sub-group met a number of times to consider, amongst other things, progress with "signposting" - a process of identifying the top categories of action needed by each species - and the desired outcomes of the review for priority habitats. Link representatives on the Priority Review Group are contributing to the group's report to the UK Standing Committee, which will present the proposed new BAP list to be signed off at the Committee's meeting on 25th April. BWG members also commented on the draft Guidance on the NERC Biodiversity Duty, which is now expected to be published in May.

Farming and Rural Development

Link wrote to Defra at the start of the quarter outlining its concerns regarding a recent report looking at possible additional landscape features in Cross Compliance, the findings of which Link believe should not be used to limit the number of features that are considered in the forthcoming consultation on Cross Compliance. During the quarter Link was also represented at a meeting of the Agri-Environment Steering Group, and Ian and Alexia met with NE to discuss its Sustainable Land Management Campaign.

The Farming and Rural Development (FRD) Working Group met in January to discuss, amongst other things, the group's workplan for this year, the delays in the Rural Development Programme for England 2007 - 2013, Environmental Stewardship, as well as an update on the Link Bioenergy and Sustainable Land Management Vision projects.

In February, representatives of the FRD group attended a Land Use Policy Group workshop, at which climate change and rural land use were discussed, and also met with the Soil Association, to discuss organic farming, climate change, and cypermethrin.

Towards the end of the quarter, Link wrote a letter to the Secretary of State for the Environment David Miliband MP, regarding the funding of Environmental Stewardship in light of current discussions in Europe. In March, Link welcomed the statement on the overall budget for the Rural Development Programme for England 2007 - 2013, and called on Defra to ensure that substantial funding is allocated to the Higher Level Scheme.

The FRD Group's Bioenergy project with Land Use Consultants (LUC) is ongoing and a report has been distributed internally.

Land Use Planning

The publication of a Planning White Paper (PWP) was expected in late March, but has been delayed until late spring - at least until after the elections on 3rd May. The PWP is expected to take forward proposals made in reports by Kate Barker and Sir Rod Eddington, both published last December.

Representatives of the Land Use Planning Working Group (LUPWG) attended a meeting with Housing Minister Yvette Cooper and Secretary of State Ruth Kelly in February, to discuss their concerns about the forthcoming reforms. Also in February, the Link Secretariat and members took part in a parliamentary event hosted by Paul Truswell MP, as part of a broader coalition of environmental and social organisations who share concerns about the expected proposals.

Water

The newly badged Water Working Group (WWG) continues to discuss opportunities for working with the newly launched Blueprint for Water coalition of environmental, water efficiency, and fishing & angling NGOs, and has still to agree a workplan for this year. Link's Director attended a Blueprint meeting at the end of February to discuss opportunities for collaboration, at which the Blueprint coalition formally asked Link to take on the Secretariat role of the group, thus bringing the Blueprint into Link as a Link campaign. Consultation with all members is now taking place and it is hoped that a decision on this can be reached shortly.

In February, the WWG responded to Defra's request for comments on the 2006 paper by English Nature and the Environment Agency on proposals for extending water bodies and identifying new ones of biodiversity significance in England under the EU Water Framework Directive. This long-awaited paper was accompanied by a cost benefit analysis on the proposed classification of additional water bodies. Also in February, the River Basin District Liaison Panel NGO representatives met for the second time to discuss progress within each district and co-operation across the environmental sector, both regionally and locally. Wildlife and Trade

The Wildlife and Trade Working Group met several times in the quarter to discuss the proposals for the 14th meeting of the Conference of Parties (CoP14), which is taking place in June in The Hague. A Joint NGO Liaison Group CITES meeting with Defra took place in January and in March, both of which focused on the CITES proposals and working documents.

In February, the group met with the Minister, Barry Gardiner MP, to discuss the role of the UK at the forthcoming CITES meeting, and NGO representation on the UK delegation at CoP14. The group wrote to the Minister following the meeting and a reply has been received declining NGO representation on the UK's CoP14 delegation.

Whales

Whaling

The Whale Working Group's activity has throughout the quarter been focused on the forthcoming meeting of the International Whaling Commission (IWC59). This has involved the writing of a number of letters including to both the Prime Minister and Foreign Secretary reiterating its calls for strong diplomatic action in the run-up to IWC59. Link members also met with Defra at the beginning of February to discuss the UK's progress towards winning back the majority and provided the Minister, Ben Bradshaw MP, with a briefing in advance of the publication of the IWC59 annotated agenda, setting out the key issues and what actions Link would like the UK Government to take. As in previous years, Link has provided a number of representatives for both the Scientific Committee and Plenary meetings for the UK delegation to IWC59.

Link representatives met with the Danish Ambassador in February to discuss the Danish pro-whaling vote at IWC58 last year. Link has also written to the Ambassador following Denmark's attendance at the Normalisation meeting and their support of the St. Kitts and Nevis Declaration. A sub-group of members has also been meeting with supermarket retailers including Morrisons, Tesco and Sainsburys, urging them not to source products from Iceland following their resumption of commercial whaling, and to ensure that the products they do source do not have any links with whaling companies.

Sakhalin II

Last year Shell signed the majority share in the Sakhalin II project over to the Russian state controlled company Gazprom. Shell remains involved in the project but only as a minority partner, and therefore it is understood that EBRD is no longer considering financing the project.

Sonar 2087

Last year Link wrote to the Secretaries of State for Defence and for the Environment to set out our continuing concerns about the effects of the recently introduced powerful low frequency military sonar system (known as Sonar 2087) on cetaceans and other marine wildlife, and about the efficacy of the mitigation measures employed. Although Link is now in receipt of a detailed response from the Ministry of Defence, there continue to be concerns which Link will be following up.

Marine

In spite of letters signed by fifteen Link member Chief Executives and Directors to the Prime Minister and the Secretary of State for the Environment, David Miliband MP, last November's Queen's Speech made no mention of the Government's commitment to a Marine Bill. However, a response to these letters (from Ben Bradshaw MP) was received in January, confirming the Government's intention to publish a White Paper, and "A Sea Change" - the Marine Bill White Paper - was launched on 15th March. The launch event was opened by David Miliband MP, who gave his assurance that the Marine Bill would come forward during this Parliament. Ben Bradshaw MP also spoke at the launch, which was attended by a number of Link members along with many other marine and coastal stakeholders.

The MTF held a number of useful meetings with Defra officials during the quarter, to discuss the White Paper as well as the future delivery of the BAP in the marine environment. In February, the MTF published an "advertorial" in The House magazine (a publication for Parliamentarians), setting out its key priorities in relation to the Marine Bill. Link's advertorial appeared alongside articles on the Bill by Ben Bradshaw MP, opposition spokespeople, and others. Please contact Annie should you require an electronic copy. The MTF is also planning a Parliamentary Reception to highlight Link's key priorities for the Bill to MPs and Peers.

Bycatch

The Bycatch group met in February. The group agreed to broaden its remit beyond cetacean bycatch to include other issues of key importance for the conservation of small cetaceans - for example fisheries related noise, and prey depletion - and will consider commissioning a review to support these new work areas. Also discussed at the meeting were the implementation of the EU Bycatch Regulation and possible Link research proposals related to this. The group also looked forward to the April meeting of the ASCOBANS Advisory Committee.

Earlier this quarter, the group submitted comments to SMRU on a protocol for their proposed acoustic and visual cetacean survey and trial of the "DDD" pinger in the South West English Channel, with survey work initiated towards the end of the quarter.

Scottish Environment LINK (LINK)

With exhibitions in the Scottish Parliament and gin tasting to promote a new study on juniper berries by Plantlife, Scottish Environment Week in February was given a high profile. The 'everyone' pre-election campaign continued with twenty hustings planned for April throughout Scotland, and the 'Big Green Debate' to be held in Edinburgh, complete with interactive audience voting and podcasts.

The 'everyone watching' end of term report, which analyses how well the Scottish Executive has done on its environmental commitments, was published in March, and its awards for the best and worst policy achievements, including the 'Blooming Thistle' and the 'Ostrich' were featured in The Scotsman newspaper.

LINK Parliamentary staff attended the SNP, Labour and Conservative spring party conferences, and LINK held a Climate and Land Use Seminar in Perth in March to update members and to help develop a common view in emerging agendas. With 1000 days left until the 2010 biodiversity target expires, the Biodiversity Task Force was involved in publishing a UKBAP report - 'Call 999 an Emergency for Scotland's Biodiversity' - which concluded that progress towards the 2010 target is not happening quickly enough.



Northern Ireland Environment Link (NIEL)

What with elections and the 'will it won't it' nature of devolution, NIEL has been concentrating on the impacts that the presumed resumption of the Assembly will have, visiting political parties and party policy officers to remind them of the importance of the environment.

Following NIEL's major conference on Landscape and Planning, it is developing an Agenda for Action for Planning. NIEL's fact sheet on Community Planning continues to be well received and it will shortly publish another on Steps to Sustainability.

The Office of the First Minister and Deputy First Minister (OFMDFM) has prepared an Implementation Plan for the Sustainable Development (SD) Strategy, but it falls short of involving all sectors. NIEL was heavily involved in a stakeholder event, and continues to promote SD to other stakeholders, particularly local authorities.

An away day for the Executive and Staff helped NIEL on its way for strategic planning for the next seven years, and affirmed the need to be active politically. Task Forces on Marine, Archaeology, Climate Change and Waste have been the most active in the past three months. NIEL still awaits news on the Review of Environmental Governance; the report is now due in May.



Wales Environment Link (WEL)

WEL members had their last six-monthly meeting with the Minister for the Environment, Planning and Countryside ahead of May's Assembly Elections. The agenda included measuring CO₂ impacts of Welsh strategies, zero carbon homes, links between the Wales Environment Strategy and the Wales Spatial Plan, coastal access and landscape characterisation work. In March, three members represented WEL at an oral evidence session with the Environment, Planning and Countryside Committee on implementation of the Environment Strategy. A supporting paper was submitted, which illustrated how well implementation of the action plan has been advancing to date, from the perspective of the environmental voluntary sector.

A number of WEL consultation responses have been drawn up recently, including responses to the UK's Draft Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2007; the Strategic Action Plan for the Voluntary Sector Scheme and the Local Service Boards/Local Service Agreements consultation. WEL's Planning Working Group also responded to the Planning for Climate Change consultation. WEL's Election Campaign working group provided the four main political parties in Wales with feedback on their pre-manifesto publications. The group is now awaiting the publication of the final manifestos to see how much influence WEL's campaign work has had.

Sonar 2087

Last year Link wrote to the Secretaries of State for Defence and for the Environment to set out our continuing concerns about the effects of the recently introduced powerful low frequency military sonar system (known as Sonar 2087) on cetaceans and other marine wildlife, and about the efficacy of the mitigation measures employed. Although Link is now in receipt of a detailed response from the Ministry of Defence, there continue to be concerns which Link will be following up.

Marine

In spite of letters signed by fifteen Link member Chief Executives and Directors to the Prime Minister and the Secretary of State for the Environment, David Miliband MP, last November's Queen's Speech made no mention of the Government's commitment to a Marine Bill. However, a response to these letters (from Ben Bradshaw MP) was received in January, confirming the Government's intention to publish a White Paper, and "A Sea Change" - the Marine Bill White Paper - was launched on 15th March. The launch event was opened by David Miliband MP, who gave his assurance that the Marine Bill would come forward during this Parliament. Ben Bradshaw MP also spoke at the launch, which was attended by a number of Link members along with many other marine and coastal stakeholders.

The MTF held a number of useful meetings with Defra officials during the quarter, to discuss the White Paper as well as the future delivery of the BAP in the marine environment. In February, the MTF published an "advertorial" in The House magazine (a publication for Parliamentarians), setting out its key priorities in relation to the Marine Bill. Link's advertorial appeared alongside articles on the Bill by Ben Bradshaw MP, opposition spokespeople, and others. Please contact Annie should you require an electronic copy. The MTF is also planning a Parliamentary Reception to highlight Link's key priorities for the Bill to MPs and Peers.

Link representatives also attended a meeting of the Offshore Energy SEA Steering Group in March.

Bycatch

The Bycatch group met in February. The group agreed to broaden its remit beyond cetacean bycatch to include other issues of key importance for the conservation of small cetaceans - for example fisheries related noise, and prey depletion - and will consider commissioning a review to support these new work areas. Also discussed at the meeting were the implementation of the EU Bycatch Regulation and possible Link research proposals related to this. The group also looked forward to the April meeting of the ASCOBANS Advisory Committee.

Earlier this quarter, the group submitted comments to SMRU on a protocol for their proposed acoustic and visual cetacean survey and trial of the "DDD" pinger in the South West English Channel, with survey work initiated towards the end of the quarter.

Scottish Environment LINK (LINK)

With exhibitions in the Scottish Parliament and gin tasting to promote a new study on juniper berries by Plantlife, Scottish Environment Week in February was given a high profile. The 'everyone' pre-election campaign continued with twenty hustings planned for April throughout Scotland, and the 'Big Green Debate' to be held in Edinburgh, complete with interactive audience voting and podcasts.

The 'everyone watching' end of term report, which analyses how well the Scottish Executive has done on its environmental commitments, was published in March, and its awards for the best and worst policy achievements, including the 'Blooming Thistle' and the 'Ostrich' were featured in The Scotsman newspaper.

LINK Parliamentary staff attended the SNP, Labour and Conservative spring party conferences, and LINK held a Climate and Land Use Seminar in Perth in March to update members and to help develop a common view in emerging agendas. With 1000 days left until the 2010 biodiversity target expires, the Biodiversity Task Force was involved in publishing a UKBAP report - 'Call 999 an Emergency for Scotland's Biodiversity' - which concluded that progress towards the 2010 target is not happening quickly enough.



Northern Ireland Environment Link (NIEL)

What with elections and the 'will it won't it' nature of devolution, NIEL has been concentrating on the impacts that the presumed resumption of the Assembly will have, visiting political parties and party policy officers to remind them of the importance of the environment.

Following NIEL's major conference on Landscape and Planning, it is developing an Agenda for Action for Planning. NIEL's fact sheet on Community Planning continues to be well received and it will shortly publish another on Steps to Sustainability.

The Office of the First Minister and Deputy First Minister (OFMDFM) has prepared an Implementation Plan for the Sustainable Development (SD) Strategy, but it falls short of involving all sectors. NIEL was heavily involved in a stakeholder event, and continues to promote SD to other stakeholders, particularly local authorities.

An away day for the Executive and Staff helped NIEL on its way for strategic planning for the next seven years, and affirmed the need to be active politically. Task Forces on Marine, Archaeology, Climate Change and Waste have been the most active in the past three months. NIEL still awaits news on the Review of Environmental Governance; the report is now due in May.



Wales Environment Link (WEL)

WEL members had their last six-monthly meeting with the Minister for the Environment, Planning and Countryside ahead of May's Assembly Elections. The agenda included measuring CO₂ impacts of Welsh strategies, zero carbon homes, links between the Wales Environment Strategy and the Wales Spatial Plan, coastal access and landscape characterisation work. In March, three members represented WEL at an oral evidence session with the Environment, Planning and Countryside Committee on implementation of the Environment Strategy. A supporting paper was submitted, which illustrated how well implementation of the action plan has been advancing to date, from the perspective of the environmental voluntary sector.

A number of WEL consultation responses have been drawn up recently, including responses to the UK's Draft Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2007; the Strategic Action Plan for the Voluntary Sector Scheme and the Local Service Boards/Local Service Agreements consultation. WEL's Planning Working Group also responded to the Planning for Climate Change consultation. WEL's Election Campaign working group provided the four main political parties in Wales with feedback on their pre-manifesto publications. The group is now awaiting the publication of the final manifestos to see how much influence WEL's campaign work has had.

Management Committee Meeting

The first Management Committee meeting of 2007 was held on 23rd March at Link's offices. Issues discussed at the meeting included Link's quarterly accounts and projected year-end figures, the recommendations of the Forward Planning process of last year, partnership working with like-minded coalitions, and the 2007 workplans of each Working Group and Task Force.

The next Management Committee meeting is scheduled for 27th June 2007 at Link's offices.



Other Link news

Following the successful application for funds for a full time Marine Policy and Campaigns Co-ordinator (for 2-3 years) to facilitate Link's Marine Task Force and ensure our campaign for comprehensive legislation is successful, there are some expected staff changes as from May this year. Annie Smith - currently Policy and Campaigns Co-ordinator - will take up the new position of Marine Policy and Campaigns Co-ordinator, and will be working full time on Link's marine campaign. Jodie Bettis, - currently Link's Information and Office Co-ordinator - will be promoted to Policy and Campaigns Co-ordinator. As a result, we are currently recruiting for an Information and Office Co-ordinator (see our website for details - closing date 19th April).

As reported last month, we are currently reviewing some of our methods of communicating with our membership. The Link quarterly report has been produced by the Secretariat for many years and has taken on many formats and incarnations.
